The club features the home course of the Sam Houston State PGA Golf Management program, the Sam Houston State University Bearkats, Huntsville Hornets, and New Waverly High.

The course itself will challenge golfers of all ability levels. The tee options range from the forward green tees measuring 5,416 yards with a course rating/slope of 69.8/121 to the most challenging black tees, which measure 6,943 yards and have a course rating/slope of 72.6/130.

Bayer Superintendent Grant Program: *Act very quickly!*

Bayer Environmental Science has teamed up with The Environmental Institute for Golf to send five golf course superintendents to the GCSAA Education Conference and Golf Industry Show.

The purpose of this grant is to assist golf course superintendents with their professional development through participation in the annual event that features the most comprehensive education program available in the industry.

Lone Star GCSA sets Raffle for Research

The Lone Star Golf Course Superintendents Association will be rolling out its latest fundraising campaign for research at the beginning of the year.

All of our state's local associations will be collecting rounds of golf to be raffled off in the first quarter of 2012. This project is very similar to the "Rounds for Research" campaign that was held last year.

Although the project produced over \$6,000 for research last year, the Lone Star GCSA Board of Directors did not feel it was as successful as it should have been. We found that the weak link in that program was getting enough people to actually bid on the rounds.

The online bidding process was very cumbersome and we lost many interested bidders in the registration phase of the project. Accordingly, changes have been made, starting with the elimination of the online portion of the effort.

Here is how we have designed the 2012 "Raffle for Research" project. In short, each Chapter will be assigned a target number of rounds of golf to secure, a target number of raffle tickets to be sold that will result in a goal for the funds it

is responsible for raising. All sales will be conducted in person by volunteer members (and affiliate members) of the respective chapters.

We have tried to keep the odds of winning at around a one in 10 chance per ticket purchased.

We hope that there will be enough volunteers in each chapter that step up to sell five tickets per volunteer. The chapters that are designated to 200 tickets, for example, would only need 40 members selling five tickets each to reach their Chapter goal. That sounds extremely possible and it puts the control of success of the project back into our members' hands.

We hope to have the rounds of golf procured by the end of November and we hope to have the raffle tickets back from the printer by the end of December.

We have allocated the months of January and February for selling the tickets, and in March, each chapter will hold a drawing to pick the winners.

Each of the chapters will hold their own drawing to insure the rounds of golf donated in that particular area will be won by someone from within the Chapter's geographic territory.

Once all of the drawings have been held, all of the 750 tickets that were sold throughout the state will then be collected and another drawing will be held (by the LSGCSA) for a chance to win one of five (and possibly more) stay-and-play packages throughout the state.

David Gray

David Gray set to host Annual Meeting

History says it's a fairly rare day when the South Texas Golf Course Superintendents Association travels outside the metropolitan Houston area for one of its "Monthly Meetings," and rarer still when it does so more than once in a given year.

You can count 2011, then, as singular—when the Chapter gathers at Huntsville's Raven Nest Golf Club on Nov. 8 for its

Annual Meeting, it will have held three of its 2011 meetings out in the country, and that might just be a first.

The site of the third of those gatherings is a first, to be sure. The STGCSA is making its first-ever trip to Raven Nest and will be hosted by Golf Course Superintendent David Gray, who has worked in Huntsville throughout his professional life.

Gray's family moved to Gonzales two years after he was born in Houston, and that's where he was raised. He headed to Blinn College after graduating from Gonzales High School, finishing up his Associates Degree in 1998.

He then transferred to Sam Houston State University and was head toward a geology degree when fate intervened. Raven Nest was then under construction and the sights made Gray curious; he met then superintendent Jerry Huntsman, gained an internship on Huntsman's staff, changed his major to horticulture and crop sciences, and was off and running.

He graduated from Sam Houston in 2002, having earned a Bachelor of Science degree, and went to work as an assistant superintendent across Interstate 45 at Elkins Lake Country Club. He stayed there for nearly five years before returning to Raven Nest and the golf course superintendent of the "home course" of the Sam Houston State University Bearcats.

Now 33 years old and a member of the STGCSA for the past eight years, Gray is excited about the prospects of having his peers visit his facility. Of what they'll find there in the way of golf, he says, "The course has a lot of long carries. You might think it would be an easy course from looking at it, but it's a grind . . . it's tough."

The course, he says, is fairly wide open. with "not that many trees" on rolling hills, adding that "staying in the fairways is key. The native grasses in the rough can be tough, but they're thinner this year because of the drought, so that might help a little."

Sounds like just what the doctor ordered for a bunch of folks looking for a getaway, and who share at least one thing in common with Gray.

"I just love getting to be outside," says Gray of his attraction to the turf management profession.

It would be unusual to find someone in the business who doesn't feel that way.


